Colorado State and Local Revenue and Spending, FY 2003-2004

Colorado remained one of the most fiscally decentralized states in the nation, with relatively strong local governments and a weak state government during FY 2003-04. Colorado was one of only four states in which the state government generated less tax revenue than the local governments. This historical pattern of weak state government has been reinforced by constitutional revenue limits adopted in the past two decades.

There are two primary ways of comparing states in terms of revenues and expenditures. The first is the per capita measure, derived from dividing the government revenue or functional spending area by the total population. The second method relates the revenue or function to the total personal income (wages, salaries, dividends, interest, etc.) of a state. As income varies widely among the states, this method takes into account these financial differences. The data in this report are from the Census Bureau's *State and Local Government Finances* for FY 2003-04, released in July of 2006. As Colorado was a relatively wealthy state in 2004, ranking 8th among the states in per capita income, it usually drops in rank when the per \$1,000 of income method, the second way of measuring, is used for comparisons.

Colorado's state and local governments received over \$28 billion in total general revenue in FY 2003-04. This included revenue from the federal government, taxes, charges, utility and insurance trust (primarily state retirement) receipts. Colorado ranked 28th among the states and the District of Columbia in per capita terms and 46th when related to the personal income of the state, as shown in Table I.

Intergovernmental revenue from the federal government to Colorado state and local governments totaled over \$5.2 billion. It included federal grants and transfers to these units. Colorado ranked 47th on both measures in Table II. Colorado's demographic characteristics of high income and a relatively young population contributed to the state receiving less federal assistance, as many federal programs are based on a per capita income formula and many programs are targeted to senior citizens.

Charges and miscellaneous general revenue totaled over \$8.3 billion, including current charges by institutions of higher education (\$1.5 billion), hospitals (\$1.1 billion), airports (\$569 million) and miscellaneous revenue of \$3 billion. Colorado placed rather high in the national comparison, 5th in per capita terms and 21st per \$1,000 of income, as shown in Table III.

Colorado's state and local governments generated about \$14.6 billion in taxes during FY 2003-04. This included such sources as property, sales, income and other taxes. The combined total gives a better overall perspective of tax burdens in an individual state as it includes tax receipts from both state and local governments. In some states, the state government is dominant, while in others local governments prevail. Colorado ranked

26th, below the national average, in per capita state and local taxes and 47th when those tax collections were related to personal income, as seen in Table IV.

The next two tables show the dichotomy of Colorado state and local taxes. In terms of state government taxes, Colorado ranked 48th in per capita terms and 49th per \$1,000 of income in FY 2003-04. Colorado was nearly \$500 below the national average in per capita state government taxes. It exceeded only South Dakota and Texas for this measure. When related to income, Colorado was 50th in the previous year in state government taxes and surpassed only New Hampshire in FY 2003-04, as shown in Table V.

While Colorado placed near the bottom in state government taxes, it ranked near the top in local government taxes, reaching the 8th spot in per capita terms and 13th when related to income. Colorado collected slightly more than \$200 above the national per capita average for local government taxes. Table VI shows that with the exception of Illinois, these states plus the District of Columbia were located on the eastern seaboard.

In separating state government and local government taxes, Colorado ranked 48th in the state government share of combined state and local taxes. Less than half (48.4%) were generated by Colorado's state government. Colorado surpassed only Texas and New York in terms of the share going to state government. Conversely, Colorado ranked 3rd in its share of taxes collected by local governments, with nearly 52% of combined taxes generated at the local level as shown in Table VII.

Table VIII displays the percentage share of major sources of state and local tax revenue on a state-by-state basis. Colorado nearly mirrors the national average for state and local property taxes. Colorado's state government receives no property tax receipts. Colorado is less dependent upon state general sales taxes than are other states. In terms of local general sales taxes, Colorado local governments are very dependent on that source. Only Louisiana exceeds Colorado among the states in that source's share of state and local tax receipts. State individual income taxes accounted for nearly one-quarter of combined state and local taxes in Colorado, compared with about 20% nationally. Finally, Colorado had relatively small amounts of all other taxes – including selective sales, corporation income, severance, etc. Alaska, Delaware and Nevada received over 40% of their total tax revenue from these other taxes.

A more detailed look at tax sources by level of government is shown in Table IX and the following three charts. Colorado is close to national averages for combined state and local taxes coming from property and individual income sources. However, Colorado exceeds the nation in general sales dependency but is lower for all other taxes as is pictured in Chart I. In terms of state government, about one-half of Colorado's state receipts came from individual income taxes. The national average was about one-third. Colorado's dependence on income taxes makes the state more vulnerable during economic downturns as income tax receipts are the first to decline. In addition, revenue from capital gains also plunge significantly during recessions and losses are deducted

during the next few years, compounding the revenue decrease. This reliance on income tax revenue lowered Colorado's share of the other tax sources as depicted in Chart II.

On the other hand, Colorado's local governments received 30% of their tax revenue from general sales taxes, nearly three times the national average of 11%. The dependence on sales taxes has significantly impacted land-use decisions in Colorado as municipalities seek to expand and enhance revenue-generating commercial property located within their jurisdictions. This has served to exacerbate fiscal disparities among local governments. Chart III also shows that Colorado was ten percentage points lower than the national average for property taxes as a revenue source. Both of these sources served to reduce Colorado local government's reliance on other taxes as shown in Chart III. While Colorado collects relatively high local government taxes, it is a result of the sales tax system and not property tax receipts.

This next section describes various tax sources and how Colorado ranks on both per capita and per \$1,000 of income basis. Colorado fell below the national average for state and local property taxes. Note that Colorado's state government receives no revenue from property taxes, as is the case for most state governments. Colorado ranked 24th in per capita property taxes and 33rd when related to income as shown in Table X. Colorado's relatively high ranking in local government taxes was not a result of the property tax component.

Colorado was slightly ahead of the national average in combined state and local general sales taxes, ranking 17th. It placed 27th when related to income in Table XI. The next two tables point out the difference between state and local governments in Colorado. Table XII shows that Colorado ranked 43rd out of 45 states in per capita state general sales taxes and 44th when related to income, significantly below the national average. Conversely, Colorado ranked 3rd in local general sales taxes on both a per capita and per income basis. As the District of Columbia placed first, Colorado was second among the states after Louisiana, which allows its school districts to levy a sales tax. Interestingly, only 35 states allow local governments to collect sales taxes and eight of those collected less than \$50 per capita. Colorado placed in the middle (25th) in per capita state motor fuels tax collections and 36th when that source was related to income as shown in Table XIV.

Colorado's largest single source of state government revenue is the individual income tax. As shown in Table XV, Colorado ranked 18th, below the national average in per capita state individual income tax receipts and 30th per income of the 43 states that levy an income tax. For corporation income taxes, shown in Table XVI, Colorado place 41st per capita and 42nd per income for the 46 states with a state corporation income tax. Table XVII shows the percentage of income remaining after subtracting state and local taxes. Colorado ranked 5th highest with 91.2% of per capita income remaining after taxes. This did not include the impact of federal government taxes.

The next section looks at spending by governmental function. It combines both state and local government in order to better compare spending categories and to account for

structural differences among states. Colorado state and local governments spent over \$28 billion in direct general expenditures during FY 2003-04. Table XVIII shows Colorado placing 25th, slightly below the national average in per capita terms and 46th in per \$1,000 terms. Note that all of these expenditure tables include the District of Columbia.

The largest functional item of both state and local government is education. Colorado state and local governments spent over \$9.7 billion on education during FY 2003-04, the largest category of state and local spending. Nearly all of the spending for K-12 was allocated to local government and most of higher education spending was apportioned to state government. Table XIX shows Colorado ranking 29th in per capita state and local spending for elementary and secondary education and 46th when related to income. Colorado placed 22nd for per capita spending on higher education and 33rd when related to income as shown in Table XX. It is important to note that higher education spending includes the tuition that students pay as well as public and private research grants and also spending on financial aid, dormitories, bookstores, etc. During the recent state budget downturn, higher education appropriations were cut in order to balance the state budget.

Table XXI shows that Colorado places 50th (out of 50 states plus the District of Columbia) in per capita and per \$1,000 on income on spending for public welfare. It ranked 18th, just below the national average in per capita terms and 22nd per income in spending for hospitals, as shown in Table XXII.

Colorado spent at a higher rate for highways in FY 2003-04. Colorado ranked 15th, above the national average on highway spending, and 22nd when related to income, according to Table XXIII. State and local spending on police and fire protection are shown in Tables XXIV and XXV. While Colorado exceeded the national average on per capita police protection but below per \$1,000, it surpassed the national average on fire protection on both a per capita and per \$1,000 basis. Colorado ranked 22nd in per capita spending on corrections and 33rd per income, both below the national average. Colorado reported its highest ranking on spending for parks and recreation at second in per capita terms and 3rd when related to income in Table XXVII. Colorado was below Nevada in per capita spending and below Nevada and Arizona when related to income.

Colorado fell below the national average in both per capita and per \$1,000 methods for community development as shown in Table XXVIII. It was also below on both for spending on health, ranking 20 in per capita terms and 26th per \$1,000 of income as seen in Table XXIX. Interest on general debt spending put Colorado above the national average on both methods of analysis, ranking 11th per capita and 16th per income according to Table XXX.

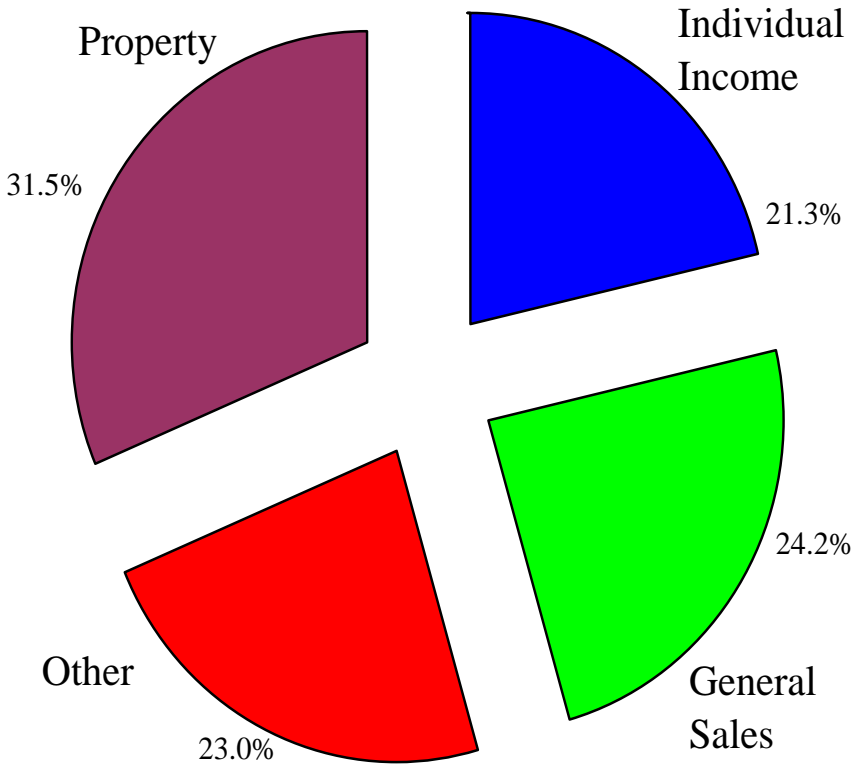

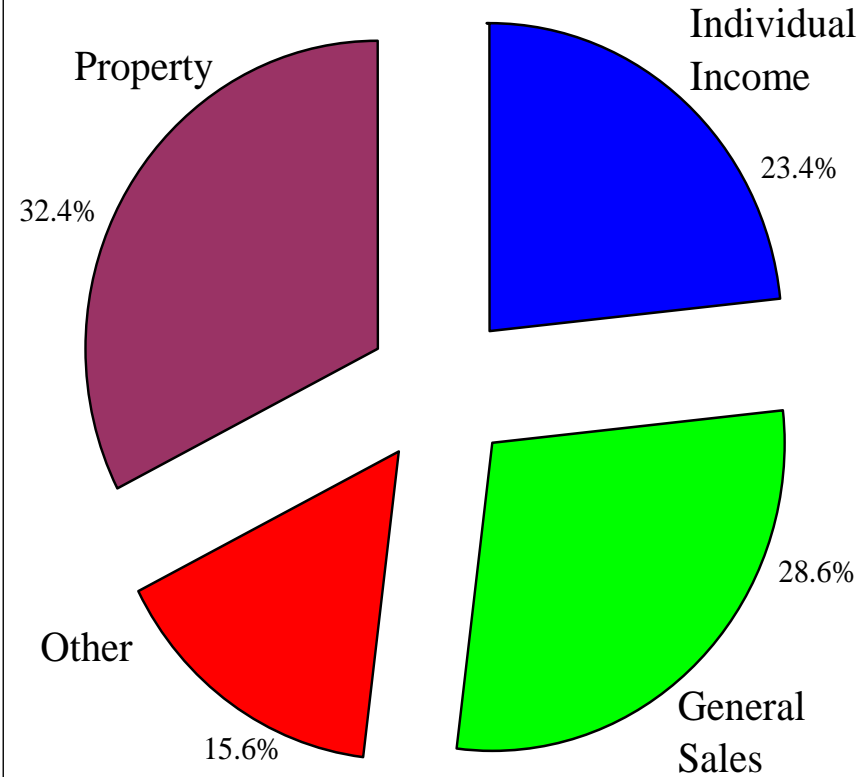
State and Local Government Percentage Share of Taxes, 2003-04, United States and Colorado

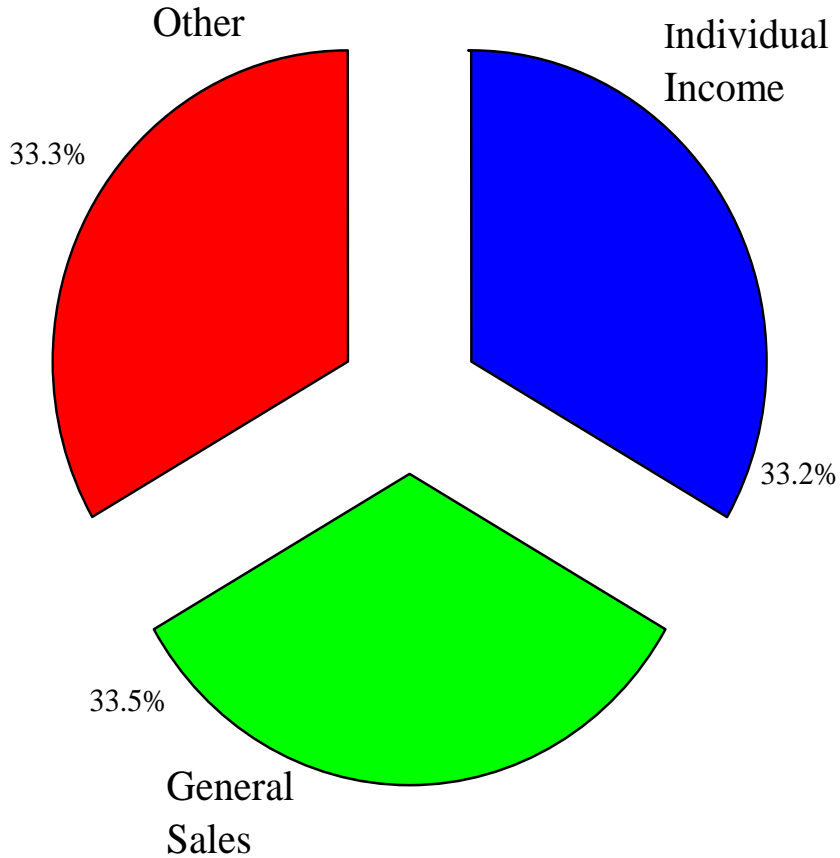

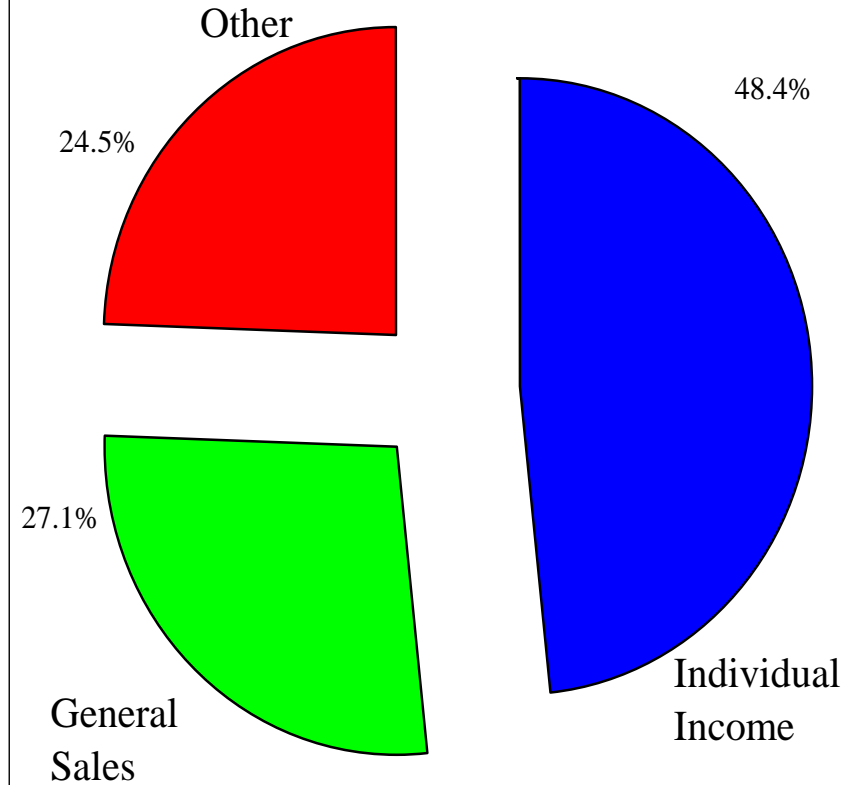
State Government Percentage Share of Taxes, 2003-04, United States and Colorado

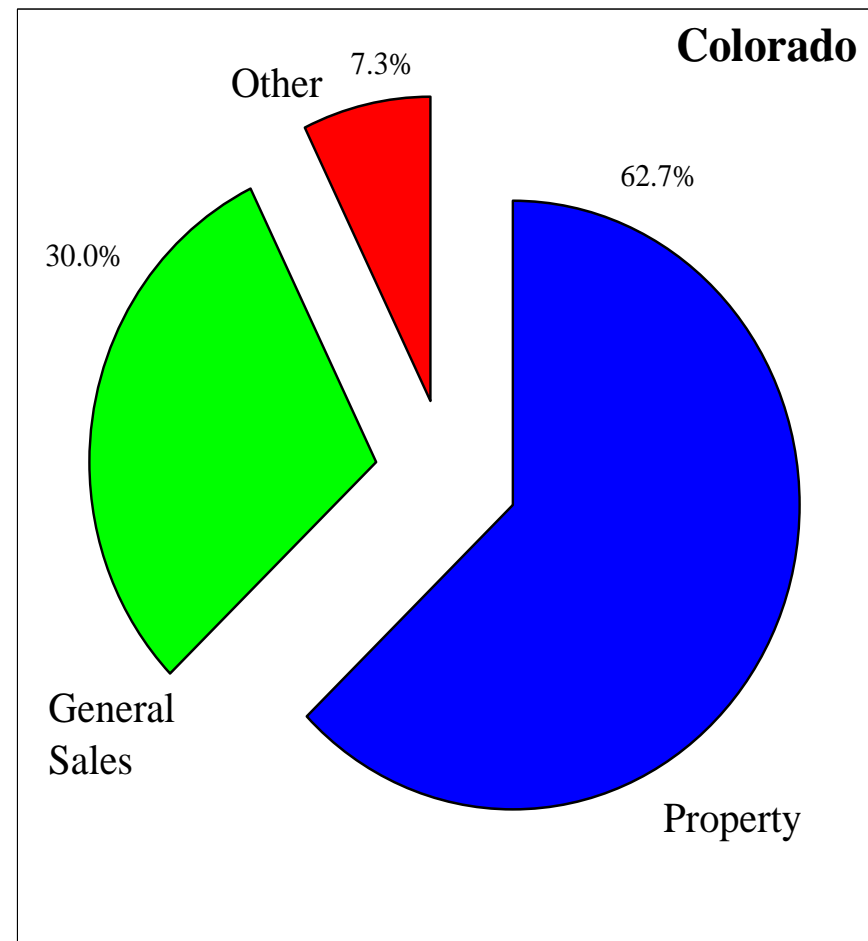
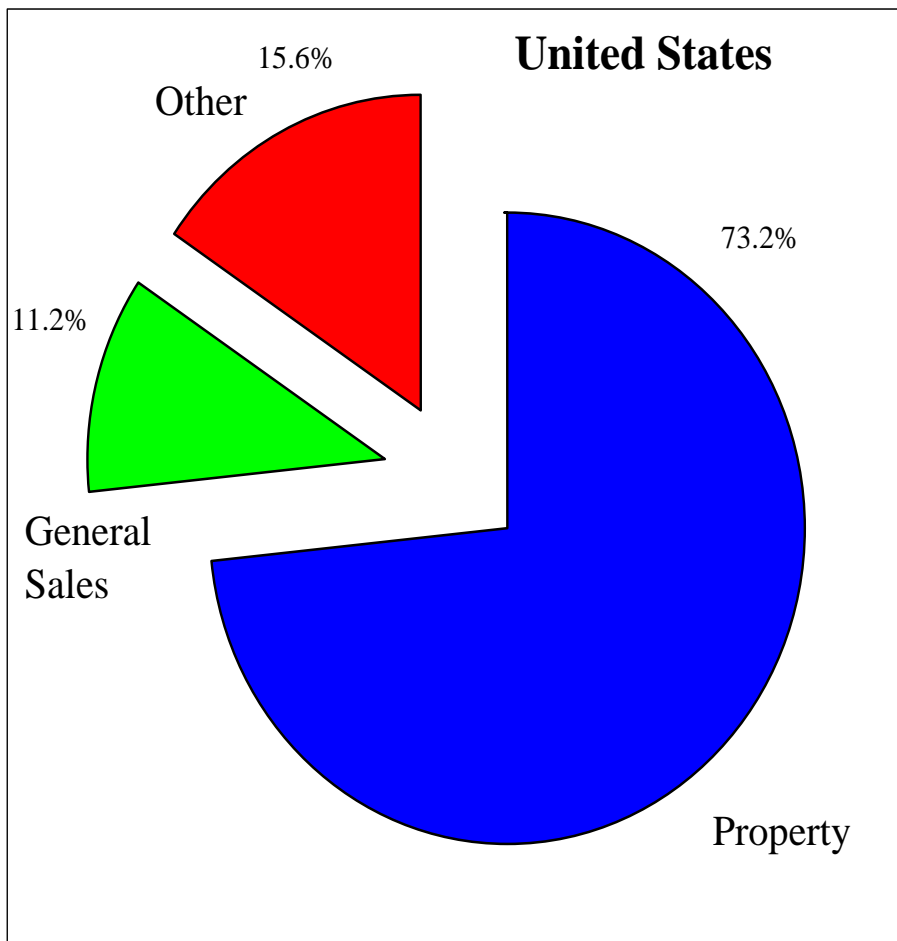
